#### PRESENT STATUS.

- All topographical survey completed.
- Gauge & Discharge observation is continuing.
- ➤ The project has obtained Techno-economical clearance from C.W.C., Ministry of Water Resources in 75<sup>th</sup> T.A.C. meeting held at the New Delhi on 18<sup>th</sup> December, 2000.
- ➤ R & R clearance obtained from Ministry of Tribal Affairs, Government of India vide their letter No.200011/8/2003-CP and R/NGO Dtd.09.06.2008. Revised R & R Plan without Buguda colony and Jhintikabari to be prepared with the alternate suitable land identified by the Tahasildar, Dasapalla in 17 villages as communicated vide letter No.2284 Dt.31.10.2013 by the Collector & District Magistrate, Nayagarh.The Revised R.R. Policy has been prepared and submitted to the D.F.O., Nayagarh vide this office letter No.868/W.E. Dt.15.04.2015.
- ➤ Environmental clearance obtained from Ministry of Environment and Forests, Government of India vide their letter No.12011/87/2005-IA-I-Dtd.02.06.2006 up to 02.06.2011.

### **SAMAKOI IRRIGATION PROJECT (BARRAGE)**

### **BRIEF NOTE**

Samakoi Irrigation Project envisages construction of a Barrage on river Samakoi near village Biralmunda at Chakdhar of Brahmani Basin in Pallahara and Talcher Sub-division of Angul district. It will provide irrigation to an area of 9990 Ha. C.C.A. out of 14,270 Ha. of G.C.A. in Pallahara Block of Pallahara Sub-division and Kaniha Block of Talcher Sub-division in Angul District and Telkoi Block of Keonjhar District.

Dt.29.08.2017 and e-filing has been done vide proposal No.FP/OR/IRRG/24883/2017, State SI. No.OR-038/2017. The D.F.O., Deogarh Forest Division, Deogarh has returned back the Diversion Proposal vide their letter No.4500 Dt.18.11.2017 for necessary compliance.
- The Executive Engineer, Cuttack Investigation Division, Jobra, Cuttack-7 has intimated to M/s O.C.C. Ltd. vide letter No.115/W.E. Dt.04.01.2018 for immediate compliance to the discrepancies as raised by the D.F.O., Angul, D.F.O., Keonjhar & D.F.O., Deogarh. M/s O.C.C. Ltd. have specified certain requirements, which may be complied by the User Agency vide their letter No.236 Dt.09.01.2018. The compliance report are attached in separate sheets.
- Total cost of the project is Rs.12538.00 lakhs. (at 2008 price level).

### HIDISING IRRIGATION PROJECT PRESENT STATUS
