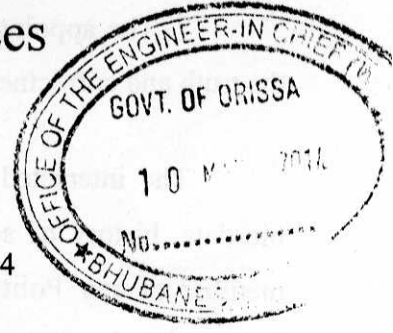

No. WR-OE-I-PFG-0015/2014 6362/WR., Application are invited from interested retired OSS Officers of the rank of A.S.O., S.O., D.O., Under Secretary, Deputy Secretary, Joint Secretary and Addl. Secretary, not above the age of 62 years and having good service records and physical fitness for engagement as "Officer on Special Duty" on contractual basis in Department of Water Resources, in pursuance of Home Department Resolution No. 42595 dated 10.10.2011 readwith No. 27395/CC dated 26.4.2012 and 22681 dated 24.06.2013.

2. The contractual engagement will be made for a period of one year and that can be extended by further period of one year subject to satisfactory performance and shall not be extended beyond attaining the age of 62 years by the contractual employees.

3. The retired officer, against whom a vigilance case or Departmental Proceeding or criminal prosecution is contemplated or pending on, who has been penalized for misconduct during the period upto ten years preceding his/her retirement, or is a member of a Political Party will not be considered for engagement.

4. Consolidated remuneration of the contractual employee shall be at the rate of his/her Last Pay+Grade Pay drawn minus the amount of pension sanctioned per month subject to maximum of Rs. 10,000/- (Rupees ten thousand) only per month.

5. The period of contractual engagement shall not be counted as Government Service for the purpose of pension and any other retirement benefit.

6. The engage officer will be subject to and will abide by the Conduct Rules applicable to the Government Servants.

7. The appointee will furnish an undertaking at the time of joining the duty in regards to the truth and correctness of the information furnished by him/her.

The interested retired officers fulfilling the above criteria may apply with his/her full bio-data, history of service in the Odisha Secretariat with an undertaking that he/she is not a member of any Polity Party and no Vigilance Case or Departmental Proceeding or Criminal Prosecution is contemplated or pending against him/her or he/she has not been penalized for misconduct during the period upto ten years preceding his/her retirement.

8. The application with all information of the applicant should be addressed to the Principal Secretary to Government, Department of Water Resources and should reach this Department by 31.3.2014.
