EXPRESSION OF INTEREST

Applications are invited from interested **Retired Head Clerks, Senior Clerks, Junior Clerks, Junior Stenographer, Senior Stenographers, Despatcher, Draughtsman, Tracers, Amins, Daftaries, Peons and Night Watchmen**, who have retired from Govt. service on attaining the age of superannuation and below the age of 65 years having good service records and physically fit for re-employment on contractual basis in Anandapur Barrage Project in pursuance of G.A Department Resolution No.23750/Gen dt.27.08.2014.

1. The re-employment shall be made **initially for a period of two years and can be extended for subsequent period of two years with spells of one year each subject to satisfactory performance up to a total period of four years not beyond the age of sixty-five years** of age in any case or till the posts are filled up by regular process whichever is earlier.
2. The retired employees against whom a **vigilance case or departmental proceeding or criminal cases** are contemplated / pending or who have been penalised for misconduct during the period of preceding five years will not be eligible for consideration.
3. The re-employment persons will be entitled for payment of remuneration as determined by the Administrative Department / Appointing Authority with the concurrence of Finance Department.
4. The re-employment persons shall be governed by the provisions of Odisha Government Servants Conduct Rules 1957 and shall be liable to be proceeded against for their misconduct, omissions and commissions as per the provisions under Odisha Pension Rules 1992.
5. The re-employment can be terminated at any time by the respective appointing authority due to unsatisfactory performance of any of the employed persons by giving one month notice. On the contrary, if any re-employed persons desires to resign he shall do so by giving one month written notice to the competent authority.
6. The re-employed persons will furnish an undertaking at the time of joining in the duty in regards to the truth and correctness of the information furnished by him/her. The interested retired employees fulfilling the above criteria may apply with his/her full bio-data, history of service with an undertaking that he/she is not a member of any political party and no vigilance case or departmental proceeding or criminal prosecution is contemplated or pending against him/her or he/she has not been penalised for misconduct during the period of preceding five years of his/her retirement.

The application with all information of the applicant shall be addressed to the Chief Construction Engineer, Anandapur Barrage Project, Salapada and reach this office **on or before 17th OCT 2016**.

The competent authority reserves the right to reject any / all applications without any reasons thereof.
