Loan No. and Title: (Loan No. 2444 – IND) Orissa Integrated Irrigated Agriculture and Water Management Investment Program

Deadline for Bids: 04.11.2010 up to 12 Noon.

1. India has received a loan from the Asian Development Bank (ADB) towards the cost of Orissa Integrated Irrigated Agriculture and Water Management Investment Program. Part of this loan will be used for payment under the contract named below. Bidding is open to bidders from eligible source countries of the ADB.

2. The Department of Water Resources, Orissa State Government (“the Employer”) invites separate sealed bids from eligible bidders for the construction and completion of following works :
