No.2268/2016, Sri Sujan Sahoo, Assistant Engineer (Civil) bearing Irrigation No.2985 under the administrative control of this Department is hereby promoted on ad hoc basis to the rank of Assistant Executive Engineer (Civil) in the scale of pay in PB-3, ₹15,600-39,100/- and Grade Pay ₹5,400/- with usual D.A and other allowances as admissible from time to time till the final outcome of vigilance case(s) pending against him or till his retirement whichever is earlier on the following conditions keeping in view the GA Department office memorandum No.14640 dt.04.07.1995 as the above order dt.06.10.2016 has been passed prior to the coming into force of G.A. Department office memorandum No.9162 dt.29.04.2017.

- (i) The promotion is being made purely on ad hoc basis and the ad hoc promotion will not confer any right for regular promotion.
- (ii) The ad hoc promotion shall survive until further orders.
- (iii) Government reserve the right to cancel the ad hoc promotion at any time and revert the employee to the post from which he was promoted without assigning any reason thereof.


On ad hoc promotion to the rank of Assistant Executive Engineer (Civil), the service of Sri Sujan Sahoo at present working as Assistant Engineer (Civil) in PR & DW Department on deputation basis is hereby allowed to remain at the disposal of PR & DW Department on deputation basis for detail posting.


