No. 11027—Irr.-II-WRC-21/2010-WR.—The issue of allocation of water from Government sources/Irrigation works of the State in favour of Industries/Commercial and other establishments is gaining greater significance with increasing industrialization of the State. The demand of water for the purpose *vis-a-vis* the availability of water and possible impact of pollution on environment needs to be thoroughly examined before allocation of water. Keeping in view the objectives mentioned above and the recommendation of the State Water Resources Board, Government in Water Resources Department have been pleased to reconstitute the Water Allocation Committee with the following members :—

The Committee shall have the following functions :

1. To consider the application of the intending users, assess the requirement of water and recommend for allocation keeping in view the sectoral demands envisaged in the State Water Policy;

2. To examine the feasibility of water drawal scheme furnished by the intending users and suggest additional storage, if any;
3. To formulate the guidelines for allocation of water for industrial, commercial and other use;
4. To examine the impact of pollution on environment and suggest remedial measures;
5. To suggest additional conditions if any to be imposed over and above the existing terms and conditions;
6. To verify overlapping of irrigation command at the time of recommendation for allocation;
7. To vet the Water Management Plan for final allocation of water;
8. To perform such other functions relating to allocation of water to the intending users as the Government may time to time require.

ORDER—Ordered that the Notification may be published in the *Orissa Gazette* and the copies of the same be forwarded to all Departments of Government/all Heads of Department/all the Members of the Committee.
