No. 22673—MIJE-(M)-05/2010-WR.—Whereas Hon'ble Supreme Court in their Ad-Interim Order, dated the 9th November 2009 while granting the leave have directed that further promotion, if any, shall abide by the final result in the present appeal in Civil Appeal Nos. 7494 and 7495 of 2009 @ SLP (C) No. 27802 and 28600/2009 -Amiya Kumar Giri and others *Vrs.* Pradyumna Kumar Puri & others

Whereas subject to the final decision of Hon'ble Supreme Court in the above -mentioned Civil Appeals, the following Jr. Engineers (C) of Minor Irrigation Cadre under the Department of Water Resources have been promoted to the rank of Assistant Engineers (C) (In Class-II Cadre) on *ad hoc* basis in the Pay Band 2 (S-12) Rs. 9,300–34,800 with Grade Pay of Rs. 4,600 with usual D.A. and other allowances as admissible from time to time with effect from the date of joining in the promotional posts for a period of one year or till the date of superannuation or till receipt of the recommendation of the O.P.S.C., Cuttack, whichever is earlier, vide DoWR Notification No. 11304, dated the 24th April 2010.
