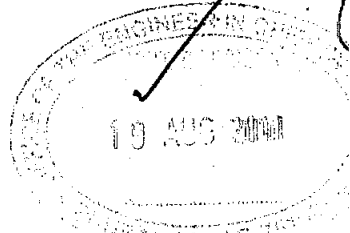


RESOLUTION

2. The Board so constituted shall function for a period of three years with effect from the date of issue of this resolution. The Board shall be an Advisory body and shall advise the State Government in all matters relating to Labour.

5. The Board shall have the power to co-operative with the approval of the Chairman, any person possessing expert knowledge on any subject that may be considered relevant to the discussion in the Board. They also have the power to form sub-committee to deal with particular subject,

6. The Board shall meet as after as necessary. It shall ordinary meet at least once in every six months. One third of total membership of the Board shall constitute the quorum in any meeting of the Board. A member of the Board representing the employer or employees shall cease to be a matter if he remains absent in three consecutive meetings of the Board without prior permission of the Chairman of the Board, in the event of any vacancy caused by ceasation of membership, Government shall fill up the membership as and when deemed necessary.

7. The non-official members of the Board shall be get traveling allowance at the rate prescribed by Government from time to time for attending the meeting of the Board or it's sub-committee. The Labour Commissioner, Orissa shall be controlling and countersigning authority in respect of the traveling bills of the matter,

ORDER: Ordered that the resolution be published in Orissa Gazettee and copies there of be forwarded to Finance Department. Accountant General (Accounts), Orissa, Bhubaneswar / Members Concerned.
