It is therefore requested that the application with required documents in respect of all Assistant Executive Engineers (C), Assistant Engineers (C) & Junior Engineers (C) who belongs to Water Resources Wing only and intend to appear the 1st half yearly Prof. Exam. 2018 may please be sent to this office on or before 31st May-2018.

Application received beyond the due date or incomplete shape will not be entertained and will be liable for rejection without any intimation.

1. The candidate having sub-divisional accounts training for a period of at-least one month and Divisional accounts training for a period of at-least 15 days will be eligible to appear the examination.
2. (i) The authority under whom the candidates under gone accounts training should furnish the Divisional & Sub-Divisional accounts training certificate in favour of the candidates. A special report regarding the candidate's physical energy and efficiency in Practical work and capacity to engage the officers is to be furnished by the officers under whom he works at present.
- (ii) He/she will be permitted to appear the examination only on recommendation of officers not below the rank of E.E. in respect of his physical energy, efficiency in proper work. While recommending the application of intending candidates, the authority concerned should furnish the Divisional & Sub-Divisional a/c training certificate and special report in respect of technical experience of the candidate.
- (iii) The above certificates and special reports are however not necessary for the candidates who has appeared any such examination previously i.e. for the repeaters who have submitted previously. The month and year of such examination first appeared and letter numbers and dates in which the certificate and special report were furnished is indicated in the application of the repeater.







The report of the committee on recommendation and observation of the President shall be sent to the undersigned along with result and mark sheet within two months from the date of completion of the examination.


