





2. The sealed bid will be received from dated 18.06.2018 to 17.07.2018 up to 3.00 P.M. by the office of the undersigned during the office day and hours.
3. The bid will be opened on Dated 18.07.2018 at 11.00 hours in the office of the Executive Engineer, S.I. Division No.II, Deuli in the presence of the bidders or their authorized agent present at the above scheduled date and time.
4. The bid must be dropped in the box having identification No. 01 / 18-19.
5. The bidders may submit their bid by post in the present address i.e. Executive Engineer, S.I. Division No.-II, Deuli.
6. The sealed bid should reach before the undersigned within the above scheduled date and time. The bid received beyond the date and time will not be entertained. The department will not take any responsibility for postal delay.
7. The bidder should clearly mention his present address with PIN Code in his bid paper and enclose the security money noted under table at Col. No. 4 in shape of Fixed Deposit of any nationalized bank payable at Baripada duly pledged in favour of the Executive Engineer, S.I.Division No.II, Deuli.
8. The security money will be returned to the unsuccessful bidder after finalization of the bid process.

9. The cost of Tender Paper amounting to Rs. 400.00 + 5% GST (Non-refundable) in shape of Demand Draft in favour of the Financial Adviser & Chief Accounts Officer, Subarnarekha Irrigation Project, Laxmiposi, Mayurbhanj, payable at Baripada will be submitted by the Bidders at the time of purchase of tender paper.
10. The bidder can inspect the vehicle at the site mentioned in the table at columns No.7 during the office day and time.
11. The bidders should write clearly their amount both in figure and words. Any difference in between the figure and words, the amount written in word will be taken in to account.
12. The successful bidder will have to deposit the full bid amount and GST @ 13.5% charged extra over the offered amount in shape of bank draft of any nationalized bank payable at Baripada in favour of the Financial Adviser & Chief Accounts Officer, Subarnarekha Irrigation Project, Laxmiposi, Mayurbhanj.
13. If the successful bidder fail to deposit his offered amount and GST charged @ 13.5% extra, the Earnest Money amount deposit with his bid will be forfeited without assignment of any reason thereof.
14. The vehicle / SR materials will be delivered to the bidder from the places of delivery mentioned in the table Col. No.-7.
15. The authority reserves the right to accept / reject any or all the bid without assigning any reason thereof.
16. As soon as the full amount of the bid money is paid by the bidder, he would acquire his lien on the auctioned materials and it will be his responsibility to look after such vehicle at his own expenses and the department will not be responsible for any damage by way of pilferage and any other unforeseen calamities and no claim on this account shall be entertained.
17. The vehicle shall be removed from the site by the bidder within seven days from issue of order at his own cost and responsibility. In case the vehicle is not lifted within seven days, ground rent @ 1% of the bid amount for each day or delay will be charged. In the event of ground rent recoverable form the purchaser exceeding the sale price deposited the purchaser will cease to have any lien of the auctioned material. The amount deposited towards the sell price will be adjusted towards ground rent and the auctioned materials will remain the absolute property of Govt.
